



CALL FOR ENTRIES FOR VOX POPULI'S ANNUAL JURIED GROUP EXHIBITION

SOLID GOLD June 6 – June 27, 2008

Guest Jurors: Adelina Vlas and Sarah McEneaney

Adelina Vlas, the Assistant Curator for Modern and Contemporary Art at the Philadelphia Museum of Art, has an M.A. in Art History and a Curatorial Diploma in Visual Culture from York University in Canada, as well as an M.A. in Curating Contemporary Art from the Royal College of Art in London where she co-curated the exhibition *Public Smog and Various Small Fires*. Previously, Adelina worked at the National Gallery of Canada.

Sarah McEneaney, visual artist, has lived and worked in Philadelphia for more than 25 years. Awards received include a Pew Fellowship in the Arts (1993), a Joan Mitchell Foundation Grant (2000) and an Anonymous Was A Woman award in 2004. McEneaney's paintings are in many private and public collections including the Philadelphia Museum of Art, The Pennsylvania Academy of Fine Arts, Rhode Island School of Design and The Neuberger Museum. In 2004 The Institute of Contemporary Art in Philadelphia mounted a mid-career exhibition of McEneaney's work. McEneaney is represented by Tibor de Nagy Gallery, NY where she had solo shows in 2006 and 2008. Upcoming solo shows include Locks Gallery, Philadelphia in Fall 2008.

Eligibility

Artists of all media are invited to submit 3 or 5 examples of completed works of art. All submitted work for consideration must be available for exhibition, if chosen.

Entry Fee

\$20 for 3 submissions, \$30 for 5 submissions. Please make checks payable to Vox Populi. Please do not send cash.

Sales

Vox takes no commissions for sales of artwork. Work not available for sale should be labeled NFS.

Liability

Accepted works will be insured for the sale price up to \$300 at the gallery for the duration of the exhibition.

Shipping

Artists are responsible for shipping artwork (delivery and pick-up) to and from Vox Populi according to the Calendar.

Installation

All work MUST be received ready for installation with proper hanging devices ATTACHED and clear instructions when required.

Agreement

Vox reserves the right to photograph accepted works for publicity and educational purposes. Vox reserves the right to reject works that differ greatly from the application. Vox is not responsible for works left after the pick-up date.

Accepted Formats For Submission:

3-5 JPEG images, saved at 72dpi/ppi resolution, on a CD-R. Images must be sized at 8" x 10". Please label each image Lastnamefirstname_1.jpg, and so forth. Each CD-R must be accompanied by a printout of each image submitted, clearly labeled.

For time based or new media, you may submit 3 or 5 2-minute clips of work for consideration. The work must be submitted on DVDN(NTSC).

Do not include original works or documents.

Application materials WILL NOT be returned to the artist.
